REPRODUCTION REQUESTS

Image Services

Use of images from the Permanent Collection and Gardens is permissible only with materials supplied by the Cummer Museum of Art & Gardens.

Any person wishing to publish or broadcast photographic reproductions must make a written request for permission. The Cummer Museum charges licensing fees for high resolution images (tiffs or jpegs) that are provided for these purposes. All requests are subject to review and approval. Costs vary and will be determined based upon intended use, available photography, and preferred delivery method. A quote will be sent outlining these costs, followed by a contract that specifies how the image may be used in your project. Advance payment is required.

The Cummer Museum does not own copyright for all works in the Permanent Collection. The Cummer Museum's licensing fees do not include any copyright fees due to the artist or the artist's estate. It is the responsibility of the applicant to obtain permission from the copyright owner or administrator. The Cummer Museum will assume no responsibility for infringement of copyright laws by third parties.

Submitting Image Request

Requests to obtain low-resolution digital images must include the applicant's contact information and refer to the image by artist/maker, title, and/or accession number.

Requests to obtain a high-resolution digital image or acquire permission to reproduce images must complete an [Application for Reproduction Permission](#). This application may be mailed, emailed, or faxed.
